JR Parrish is pleased to announce the availability of this exceptional retail property in the Capitola, California. This is a Once-In-A-Generation opportunity. For years this property was home to Outdoor World, the legendary Sporting Goods and Outfitter known throughout Santa Cruz. County.

Functionally, the building is mostly clear span, open environment. Approximately 16 foot clear height. Several double door access points allow for generous flexibility. A second level mezzanine holds a break room, offices, and supervisory view of the main floor. Below the second level is a large restroom core, additional storage and a shipping /receiving area.

This free standing 15,568 square foot building is located at 1430 41st Ave in the Four Star Center on the county's busiest and most successful retail thoroughfare. Other businesses in the Four Star Center include Verizon, Hot Elevation Yoga, Salons, Bakery and a restaurant.

Parking is ample and the Santa Cruz Metro Bus stops directly in front of the Center on 41st Avenue (Route 3A/3B). Additional convenience is the immediate access to 41st avenue as well as circulation and access via the adjacent property to Capitola Road.





